### Introduction

In a recent "Roper Survey", it was indicated that over 5 million Americans believe that they were the victims of alien abductions. Regardless of whether one subscribes to alien abductions or not, it is clear that when UFOs began as a simple concept (24 June 1947 - Kenneth Arnold sights disk-shaped objects in the sky), they have developed into a vast body of claims, reports, commentaries, theories, conspiracy, and arguments. However, at the bottom line of it all, there is but one question to be answered - what are UFOs and who are their occupants?

### Hypothesis

In response to that question there are four basic hypotheses - the Spirit Hypothesis, the psychosocial hypothesis, the psychological hypothesis, and the extraterrestrial hypothesis.

The **spirit hypothesis** suggests that UFOs and aliens are manifestations from the spirit world and are a paranormal phenomenon. Once the subjective world of the paranormal is entered, there are no constraints, and there are no proofs. When the vast body of UFO/alien phenomena is reviewed, I believe that only a small proportion of the cases can be explained in terms of spirit phenomenon. It is the cases that involve the exotic class of alien that fall into, and support the spirit hypothesis. Generally speaking, outside of poltergeists, stigmatics, and apports, there is little hard evidence manifested from the spirit realms. In fairness, there has been a vast amount of channelled information that is claimed to have originated from extraterrestrial sources; however, it is still subjective and uncorroborated. As I consider the majority of UFO/alien encounters with their associated physical evidence (marks on abductee's bodies, implants, landing site marks, etc), I believe that they originate in the physical plane (spirits have no need of ships, etc), and UFOs/aliens are effectively explained by the extraterrestrial hypothesis.

The **psychosocial hypothesis** suggests that the sighting of UFOs is essentially a psychological phenomenon that is linked to human apprehension and uncertainty in the face of the dangers inherent in modern life. Referring to this, Carl Jung said that modern society was 'dissociated like a neurotic'. While the Psychosocial hypothesis suggests reasons for UFO sightings, it does not explain what UFOs and their occupants are. Further, the psychosocial hypothesis has no explanation for a UFO's ability to leave physical traces on the ground at its landing site, and the physiological evidence of an invasive examination in the abductee. In light of this, I believe the psychosocial hypothesis to be completely worthless.

The **psychological hypothesis** suggests that UFOs and their alien occupants are the products of mental illness. Such disorders as schizophrenia, delusions, hallucinations, and false memory syndrome are cited as the cause. The theory is that a psychological condition exists in which an individual's memory is partly distorted, resulting in their identity becoming centred on the recollection of one or more traumatic experiences. As a defence mechanism, the traumatic experiences are sublimated into a UFO encounter and subsequent alien violation (hence the psychosexual overtones). The individual fervently and sincerely believes their experiences to be true; however, the experiences are delusional and objectively false. Unfortunately, the psychological hypothesis is unable to explain the physical evidence related to the marks on the individual's body and the alien implants that have been recovered. In light of this, I believe the psychological hypothesis to be flawed. I agree that some individuals have been proved to be delusional and their perceived experience was the result of psychological pathology. However, in the majority of cases, with their associated evidence and corroboration by independent witnesses, the psychological hypothesis collapses.

The **extraterrestrial hypothesis** suggests that UFOs are interstellar spacecraft containing beings from another planet. Thus far, the main reason for the extraterrestrial visits appears to be scientific in nature. However, conspiracy theorists believe that certain governments (esp. the USA) have entered into covert agreements with off world groups (including hostile greys). Thus, the aliens, in exchange for certain technology (including microelectronics), were allowed to abduct and experiment upon a set quota of human beings. Several alien bases were established in the US, Mexico, and Canada, with Area 51/S-4 in Nevada being the most publicised. Unfortunately the Aliens defaulted of the terms of the agreement and far exceeded the specified quota. The situation deteriorated further when it was discovered that in the Dulce Base, an alien genetic research facility in New Mexico, the greys were conducting hideous experiments upon their human subjects. Unfortunately, in consequence of the ever-increasing alien activity, the US government was forced to initiate a cover up and debunking campaign. However, since the early '50s, a slow process of media, TV, and movie induced UFO habituation has been introduced whereby governments will eventually make a fuller disclosure. Thus, the current trend is to gradually infiltrate information to the public via experiences published in the press, sci-fi movies, and TV programmes like X Files.

## Classification

Today, by correlating and comparing eyewitness accounts from individuals who have encountered aliens (abduction victims, etc), it is possible to identify 4 distinct alien classes, which can be subdivided into 14 distinct alien sub-classes that contain a total of 49 distinct alien types:

### Extraterrestrial Hypothesis

In the final analysis, it is physical evidence that is needed to establish a hypothesis. Following is the evidence that supports the extraterrestrial hypothesis:

- **Alien bases** - Known alien bases have been established in USA (Area 51/S-4, Hangar 18 Wright Patterson Air Force Base, and the Dulce alien genetic research centre), Canada, and Mexico.
- **Alien implants** - Physical alien implants have been found in, and removed from, human abductee victims. Typically, the implants are located in the subject's brain or in the sinuses of their skull.
- **Crash-retrievals** - There have been crash-retrievals, including bodies, at Roswell in New Mexico USA, Llandrillo in North Wales UK, and Waterkloof in South Africa.
- **Crop circles** - There are two types of crop circle associated with genuine extraterrestrial activity, namely energy extraction circles, and survey marker circles.
- **Mutilated animals** - Surgically mutilated animals have been discovered whose organs and blood were removed by techniques beyond modern surgery. This phenomenon first appeared in the late 1960s, and it has occurred in USA, UK, and Europe.
- **Photographs and films** - There is now a vast body of irrefutable photographs and film that show UFO activity.
- **Physical indications at UFO landing sites** - There is now a vast amount of documentation, photographs, and casts showing corroborative physical marks and damage at UFO landing sites.
- **Radar** - There is a large number of radar recordings (ground as well as aircraft) showing UFO manoeuvres that are beyond any craft made by man.
- **Skin marks** - Residual marks, bruises, burning, rashes, skin discoloration, abrasions, and puncture wounds from medical and genetic examinations have been noted on abductees' bodies.
